## **NATURE OF BEQUEST**

#### If named in a Trust:

"Upon the death of the Settlor, the Trustee shall distribute (specific amount, percentage of estate, residue of estate) to the Community Foundation of the North State, 1335 Arboretum Dr. Ste B, Redding, CA 96003 to establish the (NAME) Fund to be perpetually recognized and administered by the Foundation in accordance with its guiding documents and its procedures for endowed funds."

#### If named in a Will:

## a. Specific dollar amount:
