### How it works:

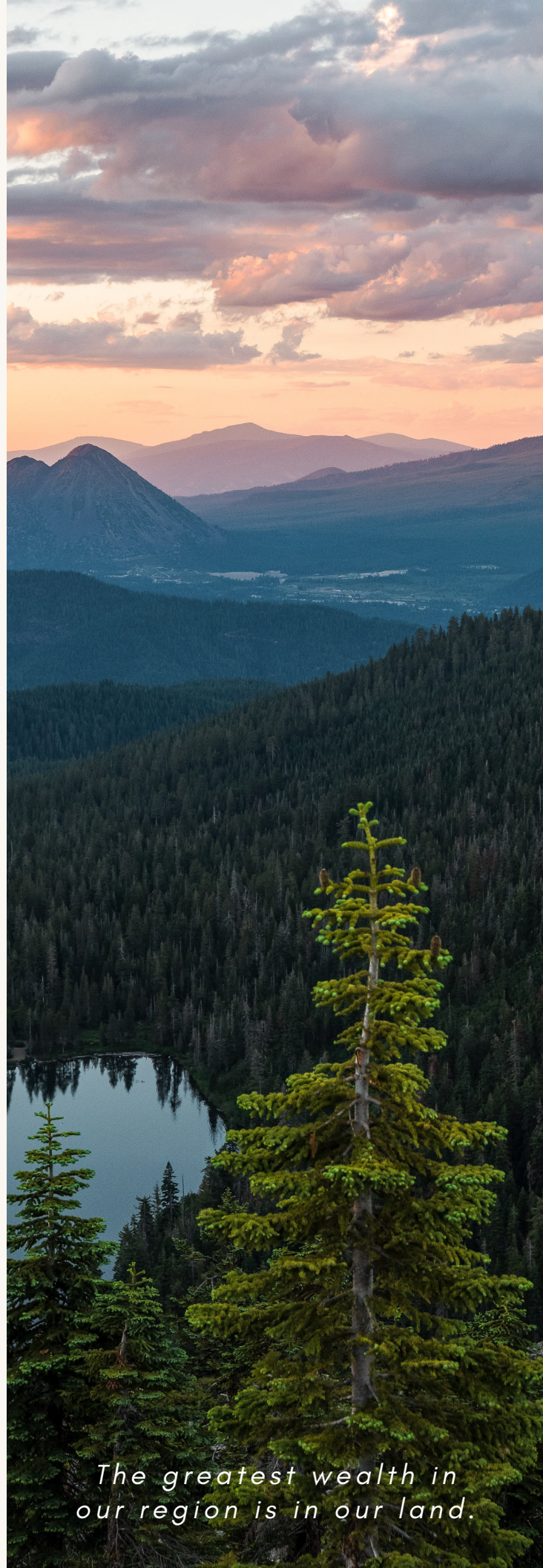
- We assess the real property you would like to donate for compliance with our acceptance policies and gather appropriate documents and information.
- We facilitate all administrative details to complete the sale of the real property including appraisals, inspections and title work.
- The net proceeds can be added to a current or new fund at CFNS. Funds are invested to grow and grant in perpetuity to benefit the cause(s) of your choice, helping to do good work forever.
- Fund options include Donor Advised, Scholarship, Field of Interest and Designated. Funds can be in your name, your family or business name, or in honor of any person or organization you choose.

## Ways to donate:

- **Generate income for yourself or others.** With a charitable remainder or lead trust, you can produce income now for yourself, your beneficiary, or charity... and still receive a deduction for a portion of the asset you donate.
